INSTRUCTION DUE TO QUARANTINE

Note: With the exception of a district closure and school closure, virtual instruction would be in place within 48 hours after the initial event, which would be on a case-by-case basis. Each time a new scenario occurs, the 48-hour period will be enacted in order to give teachers ample time to prepare. **Schedule**: We will follow the approved district calendar.

Classroom Closure where all students must quarantine but not the teacher	Teacher delivers live instruction via live streaming from the classroom to students at home	Students must have chromebooks and material (i.e., books, supplies, and other) to receive instruction
Classroom Closure where some students need to quarantine	Teacher delivers in-person and live streams to student at home *	Students must have chromebooks and material (i.e., books, supplies, and other material) to receive instruction

Classroom Closure where unvaccinated teachers and students must quarantine	To be determined on a case-by-case basis regarding the instruction delivered to students	Students must have chromebooks and material (i.e., books, supplies, and other) to receive instruction
If a student travels outside of New Jersey, Delaware, New York, and Pennsylvania with parents and must quarantine as a result	Make-up work will be provided when the student returns. If there is work that the student can do for previously taught work, the teacher has the discretion to send this home or wait until the student returns.	Students must have chromebooks to access Google Classroom work (if applicable)
Preschool students	Hybrid instruction for large group activities Individual sessions for remote student for individualized instruction (as per Preschool regulations)	Students must have a chromebook at home. Teacher prepares a take home packet of books, manipulatives, and other materials that a family must pick up (no-contact).
Other scenarios not identified in this document	Will be determined case-by-case	To be determined
Students who have been exposed by another student due to contact tracing	Teacher(s) of the student(s) must provide live-streaming within 48 hours.	Students must have chromebooks and material (i.e., books, supplies, and other) to receive instruction
