## INTERPRETIVE STATEMENT REGARDING MAYWOOD BOARD OF EDUCATION'S PETITION TO TERMINATE THE SEND-RECEIVE RELATIONSHIP WITH HACKENSACK BOARD OF EDUCATION

On August 8, 2019, the Maywood Board of Education filed a petition with the Commissioner of Education seeking to terminate its current sending-receiving relationship with the Hackensack Board of Education and enter into a new sending-receiving relationship with the Carlstadt-East Rutherford Board of Education to educate Maywood's students in grades 9-12.

The Commissioner of Education will accept written comments to the proposal to have Maywood withdraw from Hackensack High School and send their students to Becton Regional High School. The comments are required to address the following question: Will the proposed change result in a substantial negative impact in any of the affected school districts in one or more of the following areas:

- Educational and financial implications
- Quality of Education received by students
- Racial composition of the student populations?

Your comments may be no longer than ten (10) pages and the comments must be submitted within twenty (20) calendar days from November 25, 2019, to the Commissioner of Education, at the following address:
