#### **R. RECLASSIFICATION**

Director of Curriculum and Instruction - (Reclassified Executive Director of Curriculum and Instruction)

S. WHEREAS, in accordance with the PERC Act, the Hackensack Board of Education ("Board") has previously recognized that the Hackensack Education Association ("HEA") as the exclusive representative for the purposes of collective negotiations by a majority of the non-supervisory certified full-time and part-time teachers, full-time paraprofessionals, certified school nurses, guidance counselors, child study team members, librarians, therapists and full-time certified athletic trainers employed by the Board;

**WHEREAS**, in accordance with said Act, the Board has previously recognized that the Hackensack Association of Office Professionals ("HAOP") as the exclusive representative for the purposes of collective negotiations by a majority of the non-confidential secretaries employed by the Board;

**WHEREAS**, pursuant to N.J.A.C. 19:11-2.8, the HEA and HAOP have jointly petitioned the Board to acknowledge that the HAOP be subsumed by and/or otherwise consolidated with the HEA for the purposes of collective bargaining negotiations;

**WHEREAS**, the HEA and HAOP have respectively represented that there was an affirmative vote of each of their membership approving the consolidation of the HEA and HAOP;

**WHEREAS,** the Board agrees to recognize the HEA and HAOP as one collective bargaining unit for the purposes of collective bargaining pursuant to the terms and conditions of this Resolution below; and

**NOW THEREFORE**: The Board recognizes that the employees who are members of HAOP shall become part of the collective bargaining unit represented by the HEA as to the negotiations of the terms and conditions of a collective bargaining agreement for the intended time period of July 1, 2025, through June 30, 2028 ("Anticipated CBA").

While this Resolution is being ratified to recognize the above consolidated bargaining unit for the Anticipated CBA, this Resolution shall not be considered as a "past practice" or serve as any precedent as to any future representational issues involving the HEA and/or HAOP. Specifically, the Board reserves the right to dispute, challenge, and/or object to the HEA's and HAOP's

ability in the future to merge or consolidate for the purposes of jointly collectively bargaining as otherwise permitted by

applicable New Jersey law, including but not limited to requiring that the HEA and HAOP seek the permission of New Jersey's Public Employee Relations Commission for any future joint representations.

1 For purposes of clarity, secretaries to the Superintendent, Assistant Superintendent, Human Resources Executive Director, and to the Business Administrator/Board Secretary are not members of the HAOP.
