  - Leadership concerns were expressed.
  - Mr. Boateng greets parents and students and walks the building to ensure everything is in order and again during dismissal.
  - Mr. Boateng always makes himself available and engaged and that presence matters to create a sense of safety, connection, and belonging that cannot be overstated.
  - Mr. Boateng has demonstrated both heart and growth. Our children deserve leaders.
  - Speaking to support current administration at Fairmount Elementary that is there with Mr. Boateng in particular.
  - Mr. Boateng's leadership has remained evident in the building and made the transition to the school smooth and reassuring.
  - Mr. Boateng communicates clearly and with care with not just my child, but all the children.
  - Mr. Boateng no longer being at Fairmount School would be a disruption and also risk the undermining of
    positive momentum and morale that has been built.
  - Urge you to recognize the value of Mr. Boateng's contributions and to allow him to continue leading our school forward.
  - On Wednesday, February 26, a phone call was received that my son was sexually assaulted on a field trip. The teacher witnessed this. My son was targeted because he is on the spectrum and he cannot speak for himself all the time. A HIB was completed and I received a letter today that the district found that it did not meet the criteria for harassment, intimidation, and bullying. I was informed he was targeted and was told after the investigation was done that it was founded it was an HIB. The letter that was received this evening at 6:30 pm in the mail stated it was not HIB and that it was being voted on today. I would like some clarification if this was, because my son was sexually assaulted. The purpose was to make you aware because this says you have 10 days before the meeting which was written on April 25th and was not mailed until May 9th and was received today at 6:30 pm which is totally unacceptable. In addition to this letter stating it was not founded where there were witnesses is unacceptable and want it to be made aware. Board Attorney Jason Nunnermacker stated he will not let the board address that and suggest that you contact the central office tomorrow to discuss it privately for the protection of your son.

- Thank building administrators of both Mr. Boateng and Mr. Service for their efforts in collaborating with teachers, therapists, and parents in efforts to create a safe educational venue for our young children of Hackensack.
- Mr. Boateng and Mr. Service both demonstrate compassion and a desire for excellence of instruction that benefits the whole child educationally.
- Mr. Boateng is always available and is outside with the children, knows the children's names and parents, and supports the PTA.
- Mr. Boateng fully supports and provides solutions for my classroom and has been there to provide additional support for challenging behaviors while others disregard the concern for safety.
- Our children, staff, and community deserve leaders who model concern and compassion for the profession their students and our leaders demonstrate each and every day.
- Fairmont is the greatest school in Hackensack because of Mr. Boateng and Mr. Service.
- Mr. Boateng has raised the bar high.
- He makes sure that model is upheld from the younger to the older students. He leads by example.
- Mr. Boateng has a heart and passion for our future and that is what Hackensack Schools need. It takes time
  to build trust, confidence, and respect, especially when it comes to children.
- Congratulations to district employees and amazing teacher and leader Caseen Gaines who was elected to
  the city council to receive the highest number of votes on the Hackensack Unites team. It is an amazing
  accomplishment and shows dedication not only to the students, but also to the families and community to
  put himself out there in that way.
- When we look at benchmark data, it is one that is new and we are getting used to.
- NJSLA data is received regularly, it has never been made clear to me what the correlation is.
- If more opportunities to talk to each other about opportunities with what we are struggling with, and what is working would help to move forward together as one and to soar as comments as one.
- I am hoping that you will listen to the parents and to the PTA president and what they are saying about the principal.
- When parents come out and speak, I hope as a board you can collectively come to an agreement. That should show you how dedicated the man is to the children and to the families.

**Whereas,** this resolution shall be known and may be cited as the Cooperative Pricing resolution of the Hackensack Board of Education; and

Whereas, the agencies entering into contracts on behalf of the Hackensack Board of Education shall be responsible for complying with the provision of the Local Public Contracts Law (N.J.S.A 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**Whereas,** pursuant to the provisions of N.J.S.A 40A:11-11(5) the Hackensack Board of Education is hereby authorized to enter into a Cooperative Pricing Agreement with the listed agencies for the purchase of work materials and supplies, as needed;

**Now, Therefore, Be It Resolved**, that the Hackensack Board of Education is hereby authorizing the Purchasing Agent to enter into a cooperative pricing agreement with the following agencies for the purchase of work materials, supplies and services, for the 2025/2026 school year, as needed.
