D-4 RESOLUTION CORRECTING A TYPOGRAPHICAL ERROR IN THE RESOLUTION OF THE BOARD OF EDUCATION OF THE SCHOOL DISTRICT OF HACKENSACK DETERMINING THE PROPOSAL TO BE SUBMITTED TO THE VOTERS AT A SPECIAL SCHOOL DISTRICT ELECTIONTO BE HELD ON JANUARY 22, 2019

WHEREAS, on November 20, 2018 The Board of Education of the School District of Hackensack (the "Board") adopted a resolution entitled "RESOLUTION DETERMINING THE PROPOSAL TO BE SUBMITTED TO THE VOTERS AT A SPECIAL SCHOOL DSITRICT ELECTION TO BE HELD ON JANUARY 22, 2019" (the "Proposal Resolution"), setting forth the

language of the proposal seeking voter approval for various upgrades and improvements to school facilities through the school district and authorizing submission of said proposal to the appropriate parties so as to conduct a special school district election on January 22, 2019, and

WHEREAS, after adoption of the Proposal Resolution, a typographical error was noticed in Section 1 thereof which the Board now desires to correct:

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE SCHOOL DISTRICT OF HACKENSACK (not less than a majority of the full membership of the Board concurring) AS FOLLOWS:

Section 1. Section 1 of the Proposal Resolution is hereby amended to read as follows:

"At the annual election of the legal voters of this School District to be held on January 22, 2019 from 2:00 PM to 8:00 PM, the following explanatory statements and proposals shall be submitted to the voters:

EXPLANATORY STATEMENT

The Board is seeking voter approval, via a ballot question, as follows for various upgrades and improvements to school facilities throughout the School District:

<u>Proposal</u>: Construct a new school building to house students in grades 7-9, along with a new 350-space parking garage to services the current high school, and the proposed new grade 7-9 school;

Renovations, alterations, and upgrades/improvements for various existing school facilities throughout the School District.

PROPOSAL

The Board of Education of the School District of Hackensack, in our effort to bring the Hackensack Public Schools into the 21st century; to add to the recognition received; to save the district the cost of rent on ECDC; to improve internal school climate; to enhance student instruction in keeping with the City of Hackensack's revitalization efforts, and with a vision toward the future is authorized:

- (a) to undertake the construction of a new school building for grades 7 through 9 (the "7-9 School", including all work and materials necessary therefor or incidental thereto;
- (b) to undertake the construction of a new parking garage (the "Garage") with 350 parking spaces for the current high school and the 7-9 School, including all work and materials necessary therefor or incidental thereto;
- (c) to undertake various alterations, renovations, and upgrades at existing schools throughout the School District that will retrofit facilities for the

expansion of full day Pre-K in neighborhood schools, and increase capacity across the district, including:

- i) ADA accessibility upgrades and improvements; fire alarm/safety system improvements; boiler improvements; building control upgrades and improvements; classroom upgrades and improvements; electrical system improvements; facility configuration improvements; Heating, Ventilation, and Air Conditioning (HVAC) improvements; office upgrades and improvements; restroom renovations and improvements; security upgrades and improvements; stairway improvements; structural improvements; student drop off area upgrades and improvements; and window replacement at **Fairmount Elementary School**;

- iv) classroom upgrades and improvements; door hardware replacements; fire alarm/safety system improvements; generator upgrades and improvements; gym floor replacement; heating upgrades and improvements and building control upgrades and improvements; hot water pumps and heat exchanger upgrades and improvements; Heating, Ventilation, and Air Conditioning (HVAC) upgrades and improvements; lighting replacement; office upgrades and improvements; restroom renovations and improvements; roof exhaust fan improvements; security upgrades and improvements; structural improvements; and student drop off area upgrades and improvements at Nellie K. Parker Elementary School;
- v) classroom upgrades and improvements; building control upgrades and improvements; door hardware replacement; fire alarm/safety system improvements; generator/electrical upgrades and improvements; gym floor replacement; heating upgrades and improvements; Heating, Ventilation, and Air Conditioning (HVAC) improvements; partial roof replacement; playground upgrades and improvements; restroom renovations and improvements; roof exhaust fan and penthouse fan upgrades and improvements; STEAM lab upgrades and improvements; structural

improvements; and window replacement at the **Hackensack Middle** School / Upper Elementary School;

- vi) audio-visual facilities upgrades and improvements; classroom upgrades and improvements; door hardware replacement; electrical upgrades and improvements and building control upgrades and improvements; field house lighting improvements; fire alarm/safety system improvements; gym/gym lobby floor replacement and gym lighting replacement; heating upgrades and improvements; HVAC improvements; metal shop improvements; PA system upgrades and improvements; pool mechanical upgrades and improvements; restroom renovations and improvements; robotics laboratory improvements; roof exhaust fan and penthouse fan upgrades and improvements; security improvements; structural improvements; and window replacement at the Hackensack High School.
- (d) to spend for the foregoing an amount not exceeding \$169,904,226; and
- (e) and to issue bonds of the school district for the foregoing in a principal amount not exceeding \$169,904,226.

The approved State aid for school facilities projects is in the form of annual State debt service aid, with the amount of such annual State aid to be 24.36% of the annual principal and interest payable on \$169,904,226 bonds, being the final project costs approved by the State for school facilities projects pursuant to the Educational Facilities Construction and Financing Act, P.L. 2000, c. 72.
